INTRODUCTION

HOW FIDELITY TALENTSOURCE USES YOUR PERSONAL INFORMATION

Fidelity TalentSource may remove your information from its database at any time. Therefore, please retain your own copy of the information you provide to us.

HOW FIDELITY TALENTSOURCE SHARES YOUR PERSONAL INFORMATION

Personal information about you will be reviewed by Fidelity TalentSource employees or others who have a business need to access such personal information including recruiters, human resources personnel, technical services personnel and hiring managers or their designees.

Fidelity TalentSource may share personal information about you with select third-party service providers or consultants who provide services at Fidelity TalentSource's direction, such as assisting with the operation of the Website. These third parties are required to use appropriate measures to protect the confidentiality and security of personal information and use it only to provide the services specified by Fidelity TalentSource.

Fidelity TalentSource does not provide any personal information about you to Google Analytics and any information collected by Google is done anonymously without identifying an individual user. We do not associate information collected by Google Analytics with information you may have provided to us.

PROTECTING CHILDREN'S PRIVACY ONLINE

- Professional and employment-related information such as your previous work experience;
- Education Information; and
- Inferences drawn from any of the information listed above to create a profile about you, such as a profile that reflects your preferences and characteristics.
