PRIVACY POLICY

Clopay Corporation appreciates your interest in this site. This Privacy Policy ("Policy") is effective as of January 1, 2022. If we develop a relationship with you as a result of your voluntary use of this site, we will retain your information in accordance with our continuing business need to service this relationship. If you create a user account on the site, we keep your account information for so long as you are using the account. Information collected through this site is retained for 3 years following the conclusion of our business relationship with you.
